### **Workgroup and Committee Reports:**

1. **Ag Issues** – Miranda Brown, Washington Aqueduct

The workgroup is developing a message on crypto and drinking water concerns with the intent of producing a “train the trainer” factsheet and/or workshop. Dr. Rob Atwill at the University of California at Davis, has agreed to review what is developed. He is also willing and interested in coming out here to conduct a workshop(s). Once the message and strategy are solidified, the workgroup will begin engaging NRCS and state technical committees. Only after this is done will the idea of a workshop be further considered. There are multiple ways that the group is exploring to get the crypto/drinking water message out. One idea is to partner with universities or other groups to do a webinar on the topic. Penn State’s [Manure Du Jour](#) is an example of an existing forum.

2. **Disinfectant By-product Precursors** – Mohammad Habibian, WSSC

Given that the Water Research Foundation has entered a new funding cycle, there is some hope that the project to assess the relative contributions of land-based and water-based sources to DBP precursors will receive funding.

3. **Early Warning/Emergency Response** – Cherie Schultz, ICPRB

The letter to Colonial Pipeline that was distributed at the last meeting has been reviewed and approved by the workgroup. Joe Hoffman of ICPRB will sign and send the letter. The group is now considering the best way to transfer information to the Colonial Pipeline national office.

Cherie is in the process of scheduling a meeting between state primacy agencies and utilities regarding the unified command structure and interstate communication.

The workgroup has drafted a 1-page description of interstate notification procedures and travel time estimates. Please send any comments to Cherie Schultz ([cschultz@icprb.org](mailto:cschultz@icprb.org)).

The next workgroup meeting is scheduled for September 22.

4. **Urban Issues** – Traci Goldberg, Fairfax Water (for Greg Prelewicz)

NPDES permit language – The group’s strategy is to focus on the principles they would like to see in permits, instead of proscribing specific language. A letter is being developed that can be sent to each state (or relevant agency with permitting authority) which outlines in general what the workgroup would like to see. The group will consider commenting on individual permits as needed.

The Montgomery County MS4 permit program appears to be moving forward. The workgroup would like to arrange for an information session at an upcoming quarterly meeting.

The workgroup is developing a workshop to address water quality standards and source water protection. One goal is to determine which standards the utilities think need to be developed. Contact Greg Prelewicz ([gprelewicz@fairfaxwater.org](mailto:gprelewicz@fairfaxwater.org)) with ideas on topics, speakers, and/or attendees. The tentative timeframe is spring 2010.

MWCOG is holding a green transportation meeting on November 15, 2009. It will address issues such as retrofitting roads to for water quality and meeting MS4 and TMDL requirements. More information will be distributed as it becomes available.

The workgroup's next conference call will be on September 15 at 2pm.

5. **Reaching Out** – KR Young, PADEP

A Partnership satisfaction survey was distributed. It also appears at the end of the meeting minutes. The workgroup is also looking for guidance on a plan for the future direction of the Partnership in terms of expansion and marketing to others in the watershed.

The workgroup is starting to plan for the annual meeting that will take place on Tuesday, October 20, 2009. Loudoun Water has offered to host the meeting at the Broad Run Reclamation Facility. 6. **Emerging Contaminants** – Pat Bowling, PADEP

The workgroup drafted [comments](#) on the Drug Enforcement Administration's [request for input](#) on the disposal of controlled substances by persons not registered with DEA in March. The comments were submitted by ICPRB on behalf of the Partnership.

Utility members of the workgroup drafted [comments](#) to an Environmental Protection Agency Information Collection Request regarding a [Questionnaire for Drinking Water Utilities Participating in Emerging Contaminant Sampling Program](#) in June. The comments were submitted by the Metropolitan Area Utility Source Water Protection Committee.

The workgroup decided not to comment on a D.C. bill regarding pharmaceutical disposal because it is not a source water issue due to the outflow location of D.C.'s wastewater below intakes. Tom Jacobus of Washington Aqueduct testified at the hearing ([video of hearing](#) – June 25, DC Council Committee on Health).

Sampling for the emerging contaminant study being conducted by PADEP and USGS is wrapping up. This study included two sampling sites within the Potomac River basin. The written report should be available in 2010.

A new study from the USGS, [Anthropogenic Organic Compounds in Source and Finished Groundwater of community Water Systems in the Piedmont Physiographic Province, Potomac River Basis, Maryland and Virginia, 2003-04](#), is now available. A number of Partnership members had the opportunity to review the report before it was completed. This was greatly appreciated and members hope that this sort of inter-agency communication and collaboration will continue.

The EPA, in collaboration with a number of partners, is working to develop a basin-wide program on the prudent disposal of drugs. At the moment, a pilot project is being considered for Frederick County, MD, in hope that the program can be expanded to the entire Potomac basin at some point in the future. The workgroup plans to be involved with this initiative. Marjorie Copeland ([Copeland.Marjorie@epamail.epa.gov](mailto:Copeland.Marjorie@epamail.epa.gov)) of EPA's Office of Ground Water and Drinking Water is the point of contact for the project. More information will be distributed in the coming weeks.

**Project 4169 Update** – Mohammad Habibian, WSSC

The final contract has been approved and the scope of the project is being finalized. There will be two upcoming workshops associated with the project.

**Conflict of interest when commenting on regulations** – Karin Bencala, ICPRB

This was raised to clarify procedures when the entire Partnership is unable to sign comments, letters, etc due to a conflict of interest with their agency and the issue at hand. The membership is still happy to have the government or utility committee comment when the entire Partnership is unable to do so, but everyone would still like a chance to review and comment before official documents are sent out. It was recognized that there is more weight behind what we do if we can get the whole Partnership to sign on.

**Annual meeting preparation** – KR Young, PADEP; Karin Bencala, ICPRB

The Reaching Out workgroup will take the lead on planning the meeting, but is looking for volunteers to assist with the planning. ICPRB and the Partnership Chair (Bob Summers/John Grace) will share the responsibility for putting on the meeting with the workgroup.

Loudoun Water has offered their meeting space at the Broad Run facility for the meeting. The location will be confirmed shortly.
